This is the Privacy Notice for Transom Consulting Group, LLC (dba Actionist Consulting). Actionist Consulting ("we", "us", or "our") understands that your privacy is important and we are committed to protecting your personal information in accordance with this Privacy Notice.

This Privacy Notice explains how we collect, use, share, and safeguard personal information when you interact with us through our websites, services, events, and other business activities.

Actionist Consulting may, in its discretion, amend this Privacy Statement from time to time. To ensure you are able to remain informed about the information we collect and how we use it, material changes to our statement will be reflected here.

#### **Personal Information We Collect**

We may collect personal information directly from you such as your name, contact details, payment information, job title, company, areas of interest, demographic details, and other information you provide. Where permitted under applicable local laws, we may also collect personal information from third party sources, such as:

- Our business partners, vendors, and suppliers
- Your employer (if you are our client's employee)

- Data enrichment services

Categories of personal information we collect include:

- Identifiers (name, email, phone, online identifiers)

- Demographic information
- Background/application information for job applicants

We do not knowingly collect personal information from children under 16 and request that no such information be submitted to us.

#### **Use of Personal Information**

The purposes and uses of your information will depend on the information provided. We may use your personal information for business purposes such as:
